**NORCROSS LTC RULES – MARCH 2014**

1. No member shall be allowed to play on the courts until the relevant subscriptions have been paid.
2. Members under the age of 18 are considered to be junior members however junior member turning 18 during a Norcross Tennis Club Subscription Year (1<sup>st</sup> May – 30<sup>th</sup> April) will be considered an adult for subscription purposes.
3. Recognised tennis attire shall be worn.
4. Members and visitors should inspect the playing area before play to ensure players' safety.
5. Members shall be entitled to book a court using the online booking system provided that the court is available and that they adhere to the terms & conditions of the online booking system as set out by the committee at their discretion.
6. Members with court bookings will take precedence over members turning up for ad-hoc play.
7. Where a court is not booked and other members are waiting to play, those playing must leave the court after one tiebreak set. A tiebreak set is where a tiebreak (first to 7 or two clear points after 6-6) is played if the score in games reaches 6 -6.
8. Last players to leave the courts shall be responsible for leaving the nets correctly tensioned so that they will not touch the court surface and for leaving in order any equipment used. It will also be their responsibility for secure custody of balls, to secure the gates and scrambling the locks.
9. Junior members under the age of 14 must be supervised by an accompanying adult.
10. A copy of the rules will be issued with each new application for membership.
11. The Match Secretary will select the 1<sup>st</sup> team members and subsequent captains, in descending order, will select the members of their team.
12. Nothing to be placed on the Pavilion Notice Board without the approval of a Committee Member.
13. Under no circumstances should any item be removed from Norcross Tennis Club unless it is either a waste item or permission has been sought from the Chairperson, Secretary, Treasurer or Social & Domestic Committee member.
14. All members should treat any and all property relating to Norcross Tennis Club with due care and attention.
15. All members are solely responsible for their own actions.
